Who is eligible?

The scholarship is open to all students who are fully or **partially self-funded** and who have successfully **enrolled** on one of the ESCP Business School London Campus Specialised Master programmes before the scholarship application deadline.

Eligible programmes: MSc in Digital Transformation Management & Leadership (MDT), MSc in Energy Management (MEM), MSc in Marketing & Creativity (MMK), MSc in Economics & Policy for Business (MEP).

If a section does not apply to you, please indicate that it is not applicable (N/A). You will also need to submit a personal statement (see Section 2).

Your eligibility to receive the partial scholarship will be considered via this application form. Please make sure you complete the form with all the relevant documentation and that you respect the stated deadlines.

You are required to provide supporting documentation relating to income, appropriate to your circumstances. If photocopied/scanned documents are submitted, original copies may be requested from you at a later stage. If documentation is not in English, a certified translation must be supplied.
