

MSc in Energy Management (MEM)

World Citizen Talent Scholarship - Application Form & Guidance Notes

Who is Eligible?

The scholarship is open to all self-funding applicants for the September 2019 intake of the MSc in Energy Management programme who are also citizens of an emerging market country and/or consider that their cultural background can significantly contribute to the international classroom at ESCP Europe Business School. Candidates will only be considered for this award if they have successfully completed the admissions process and are offered a place on the programme.

Criteria for awarding the scholarship

The scholarship will be awarded on the basis of future professional and leadership potential, as demonstrated by the quality of the essay submitted in support of the scholarship application. We will also be looking for candidates that can demonstrate a proven track record of success (educational and professional) through their MEM programme application form and performance during the interview. The Admissions Committee will review all elements of your application to assess your potential contribution to the success of the MSc in Energy Management and commitment to ESCP Europe Business School through ambassadorial work.

Amount of the award

The scholarship amount is £3,000. It may not replace the deposit required to secure a place in the programme. The scholarship award will be credited to the student's tuition fee account.

Judging panel

The judging panel is made up of members of the Admissions Committee and includes representatives from the ESCP Europe Faculty and the MEM Programme Director. All candidates will be notified of the outcome within four weeks of their scholarship application submission.

How to apply

You must submit the following documents:

- € Completed scholarship application form and supporting documents
- € A 500-word essay answering the following question:

'As a global citizen, please outline how your cultural background will contribute to the multinational nature of ESCP Europe Business School and the MSc in Energy Management. In your answer, please discuss your contribution beyond cultural diversity.'
