Candidates should also demonstrate high level research orientation, skills in developing and expanding relationships with companies and professional organisations and extend the reputation of ESCP Business School locally and internationally.

Candidates should have the following characteristics:

- A Ph.D. in a related field. Even if an outstanding doctoral dissertation is required for the application, we will also consider candidates who are in the final stage of their doctoral thesis;
- Evidence of (or clear potential to achieve) excellence in research (publications in leading journals in the field, and/or highly innovative research);
